

## **ORDINANCE NO. 24-04**

### **AN ORDINANCE AMENDING AND RE-ENACTING CHAPTER 10-03 GARBAGE, REFUSE, AND RUBBISH, SECTION 10.0308 GARBAGE COLLECTION FEES AS AMENDED, OF THE REVISED ORDINANCES OF THE CITY OF HEBRON, MORTON COUNTY, NORTH DAKOTA OF 1971**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEBRON, MORTON COUNTY, NORTH DAKOTA, AS FOLLOWS:

That Section 10.0308 of the Revised Ordinances of the City of Hebron, Morton County, North Dakota, of 1971 and all subsequent amendments thereto is hereby re-pealed and re-enacted under this Ordinance as follows:

10.0308. **Garbage Collection Fees.** For the collection of garbage and rubbish by the City and the disposal thereof, there is hereby fixed and established the following schedule of monthly fees and charges.

1. For each water meter or family unit charge as established by the water department of the City in a residence, the sum of \$20.00 shall be charged for regular garbage container collection and the sum of \$2.00 shall be charged for city landfill maintenance.
2. For each commercial establishment, regardless of the nature thereof, from which garbage or rubbish is collected, a minimum charge of \$35.00 per month, plus such additional amount as may be fixed and determined by the City Council after a study of the kind and quantity of the garbage and rubbish or other factors incident to the collection thereof are determined, a schedule of such charges shall be filed in the office of the City Auditor and be available for public inspection. There shall also be charged for each such commercial establishment a monthly landfill maintenance fee of \$2.00.
3. Garbage dumpsters, whether residential or commercial, shall have the following collection rates:

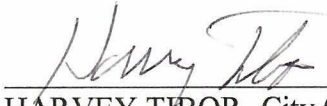

| 1                          | \$ 35.00                    | \$ 50.00     |
| 2                          | \$ 50.00                    | \$ 65.00     |
| 3                          | \$ 65.00                    | \$ 80.00     |
| 4                          | \$ 80.00                    | \$ 95.00     |
| 5                          | \$ 95.00                    | \$110.00     |
| 6                          | \$110.00                    | \$125.00     |
| 7                          | \$125.00                    | \$155.00     |
| 8                          | \$155.00                    | \$180.00     |

**SEVERABILITY.** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed and rescinded.

**SAVINGS CLAUSE.** If any provision of this Ordinance or it's application to any person or circumstance is held invalid, the remainder of the Ordinance or the application of the provision to other persons or circumstances is not affected.

**EFFECTIVE DATE.** This Ordinance shall be in full force and effect after its final passage and approval.
